## **Funding Fees Policy**

#### Please note:

- From April 2024, eligible 2 year olds will be able to access a 15 hour entitlement place, from the term after they turn 2. From September 2024, eligible children aged 9 months + will be able to access a 15 hour entitlement place, from the term after they turn 9 months. From September 2025, eligible children from 9 months to 2 years old will be able to access a 30 hour entitlement place, from the term after they turn 9 months.
- The 15 hours for 2 year olds whose family meets the disadvantaged criteria, universal 15 hours and extended 15 hours for 3 and 4 year olds will all remain the same as far as delivery to the family is concerned.
- Free funding is for 38 weeks per year, any additional hours of childcare provided will be
  paid for by the parent at the going hourly rate, e.g., if a family is funded for 30 hours and
  they want 40 hours they will have to pay an additional 10 hours of child support at my
  hourly rate.
- Voluntary Supplementary fees will be charged daily for consumables such as all meals and snacks.
- Families will have the option to provide food or consumables if they wish reducing the daily supplementary fees.

### How will it work:

The application process for the new entitlements will work in the same way that it currently does for the 30 hour codes.

• Eligible families will need to apply for their funded entitlement place on the government childcare service, the term before they wish to take it up.

# **Funding Fees Policy**

- If eligible, you will receive an 11 digit code which you must reconfirm every 3 months
  even if you haven't started their entitlement place yet. Please provide this code to me
  to put in the portal.
- Your code will have a start date, end date and grace period end date.
- A child cannot start or move whilst in their grace period.
- You can only start the full term after the child's birthday or eligible age.

### Additional costs:

- Hours not used if your child is ill or you take a term-time holiday, we will try to provide these
  hours elsewhere, but cannot guarantee that we will have a space.
- Late collection fee -If you collect your child late, you will be charged a late collection fee.

  Please see our late collection policy for more information.
- **Notice period** if you leave us mid-term, we will take advice from the local authority.
- **Settling in sessions** are not offered as part of the funding and are free of charge. Please see the contract to get more information regarding settling in sessions.

**Policy renewal date**: We will review and renew our policy as necessary within the guidelines from Govt and local authority.
